In closing, I, along with the entire Delta Section Board, including the Young Professionals look forward to hearing from you so that we can better serve you.







TH**E P**ENDULUM

The very excellent presentation by Mr. Rick Fowler of LLOG on the Delta House and really the Who Dat projects at our October section general meeting brought back thoughts about the changes that have occurred in our industry. It was not only truly amazing that those facilities were installed in that short time period considering our industry working environment, but more importantly Mr. Fowler mentioned \$50 a barrel oil would reach the breakeven point on recovery of the funding. They were fabricated, quick to sales projects. Could that be a sign of things to come in our industry? We may need to survive on a projected

stabilized price of \$80.00 per barrel oil. Does our industry expect to generate profits that are satisfactory when the product we sell may be at a price that is below the present cost foundation? The usual initial pressure on drilling contractors and service suppliers alone is not going to reach this goal.

"OLD GUYS" need to be careful they do not live with memories of the good old days. There are no doubt government regulations, in some cases probably an over kill, that have run up cost. However, LLOG worked through those legal requirements so that argument is at least dampened. Are the huge staffs going to be returned when activity increases? Can the industry afford that type of staffing with less than \$100 a barrel oil?



These are observations from an "Old Guy" who was at one time heavily involved in the industry and the engineering of many huge projects all over the world.

1) Experience. The difficulty of transportation and housing often limit engineers' offshore exposure. As a result some decisions are not always as sound as they should be. The consultants in particular do not often get opportunities to see what they are engineering. Mistakes and "over kill" are costly.

2) The slow separation of service company personnel from the decision making process at the design level has hurt. This is compounded by the service companies downsizing offices due to economic pressure. At one time the service company representatives were involved from the start of a project. The engineers usually knew many of these people from working with them previously, even at the field level. Trust, confidence and joint effort were effective. Today even major service companies have sales people who really are not sound engineers that can be of help. They are often messenger boys.

3) Procurement and specifications must be stream lined. Operators need to settle on suppliers they trust and limit the suppliers. Trusted suppliers who furnish material on a regular basis will know what the operator expects. Bidding and specifications are very expensive as well as bid evaluation. They use many staff man hours. The failure of a trusted supplier must simply eliminate them as a source. There are ways to do this, but this column does not allow for specifics of all of them. Procurement must be expedited.

It may be time to have the pendulum swing and the industry have knowledgeable staff making quick but solid decisions. Is that the way LLOG did these major projects so quickly with a \$50 base for an economic breakeven?

Overview of Presentation and Seminar

This presentation and seminar is intended to provide participants an introduction to the concept of, and guidelines for, professional ethics in the practice of petroleum engineering. This subject is of clear relevance in improving the public perception of our industry and preserving our individual personal and professional integrity. We believe the discussion will be of interest to all participants because we all encounter situations where the potential for conflicts of interest, limitations of technical competence, or compromises between professional judgment and economic or political forces arise.

The formal presentation will begin with a brief review of ethical guidelines from some of the relevant professional societies and boards. It will continue with some examples of the kinds of ethical questions that arise in actual practice of drilling, production, completion, reservoir, and environmental control engineering. We will discuss these examples and the resulting challenges that are inherent in implementing good ethics from the different perspectives of a consultant, an industry employee, and a supervisor. The ethics discussion will provide 1.5 hours of PDH and fulfill the requirement of one full hour (1-PDH) of continuing education on ethics for registered professional engineers.

Speaker Biography

John Rogers Smith retired from Louisiana State University in Baton Rouge where he was an associate professor and held a Campanile professorship. He is a registered, professional Petroleum Engineer in Louisiana. He earned a BS in Electrical Engineering from UT Austin and a MS and Ph.D. in Petroleum Engineering from LSU. He has over 20 years of industry experience in drilling, production, research, and reservoir activities. John is a life member of SPE and a long-time member of the SPE Delta Section.
